## Appointment

 Sharon Glazer appointed as Associate Treasurer, October 1, 2007.

 Report is based on data available to Associate Treasurer from about October 2007.

#### Overview

- Resources of the Association have been quite stable.
- Membership is approximately the same as it was at the Spetses conference; some increases in the number of probationary members.
- Current total equity of the association is \$138,908.05.
  - Of this, at least \$15,000 is to be dedicated to the Triandis fund.

## Membership

- Year of prev Congress (2006): 531 active members
- 2008 so far (July 12): 644 active members
- Multiple dues reminders:
  - Regular mail and email
  - Several returned envelopes; many of these members have been contacted and we have updated their profiles with their current address.

### Membership

- Total 922 members
  - 65 countries
  - 644 in good standing
  - •278 probationary members (dues in arrears 1-2 yrs)
- Majority of active members in USA & Europe
  - **0**254 in USA
  - •236 in Europe
    - 66 in Germany
    - **O**35 United Kingdom
  - **0**131 Asia
    - •36 Japan
  - o61 in Canada
  - 42 in Australia, New Zealand & Guam
  - 40 Middle East
  - 30 in Central and South America

## Payment Method

- On-Line Payment System through PayPal, began January 27, 2008.
- 40% of renewing or new members have processed their dues on their own through PayPal vs. any other mode of payment.
- About \$22,000 of dues were accrued through this form of payment.
- The Office of the Associate Treasurer processed all other payments.
  - •35% credit card payments
  - 25% cash or check payments

#### **Publications**

- Of the total expenses for the period, subscriptions to the *Journal of Cross-Cultural Psychology* (nearly 30%) comprise the major portion.
- Nearly \$12,000 was reimbursed or paid out to the Editor of JCCP.
- The Bulletin expenses are about \$5000 per issue.
- IACCP also receives royalties from Sage.
  - April 2007: \$48,502.41 in Sage royalties
  - April 2008: \$50,128.39 in Sage royalties



# Assistant to the Associate Treasurer

- Since October of 2007, the Assistant to the Associate Treasurer, Caleb Smeraldo, a graduate student in I/O Psychology at San Jose State University, has been a tremendous help.
- Caleb has been averaging approximately 15 hours per week at a rate of \$15 per hour.
- Since October 2007, Caleb has been paid nearly \$3500.00.

# Funds, Awards, Contributions

- •\$27,604.04 in dues contributions since October 2007
- Distributed ~\$20,000 in funds
  - 17 received part of these funds through Witkin/ Okonji award (\$10,000 distributed)
  - •\$5000.00 distributed for the ARTS program
  - •\$5000.00 seed money for this congress
  - \$500 cash award, up to \$1000 travel expenses, 1 year IACCP membership to the Harry and Pola Triandis Dissertation Awardee

### Donations from SJSU

• Department of Psychology at San Jose State University has paid for all photocopies (totaling app. 2500 sheets), estimated at a cost of \$250.

• SJSU also provides a mailbox for IACCP, and a telephone line at no expense which is used to contact members when needed and to send faxes.

## Summary

- Overall, IACCP Treasury has seen an increase in membership.
- Funds and savings are growing steadily.
- PayPal has been a helpful mechanism for processing funds and updating membership profiles.
