# PRESIDENT'S COLUMN

#### "Do Not Take Sides. Take Action."

In times of turmoil, when human suffering is broadcast into our homes and hearts daily, it is only natural that our members turn to IACCP with the question: What can we do?

Often, these calls come in the form of petitions urging the Association to issue statements condemning one country or another. These petitions emerge from a profound sense of moral responsibility – the desire to act, to voice outrage, to stand with victims of violence and injustice. Yet, as a scientific community representing members from nearly every corner of the world, the question for us is not whether to care, but how to care responsibly.

In the past, these moments have left us struggling as we debated the same dilemma: should IACCP condemn a country? Would doing so align with our mission, or would it risk alienating our members and compromising our integrity as a global scientific association? We issued the following statement more than two years ago. Despite best intentions, our responses often left some members dissatisfied, as they expected a stronger and more explicit moral stance.

## Commitment to Science and Compassion: IACCP's Values in a Diverse and Complex World

The International Association for Cross-Cultural Psychology is a highly diverse scientific society committed to advancing our understanding of the intersections of psychology and culture. We prioritize the application of scientific methods to deepen our insights into the human condition and to contribute to a more compassionate world for every individual. We reject violence, including terrorism, as a means to resolve interpersonal and international conflicts. We believe that all lives hold equal worth, transcending the many collective and individual identities that distinguish us. We extend our heartfelt sympathies to those who endure physical and emotional suffering, including our members and all those affected by violence, and the increasingly frequent natural and human-induced disasters.

When I began my term as President, I felt the urgency to revisit this question, but also the responsibility to approach this issue. At our Bali Congress in 2024, we held an open forum on "Institutional and Individual Neutrality in a Polarized World." The discussion revealed a shared conviction: condemnation of a country is not the only, nor the most effective, form of moral action. As participants wisely expressed, we must not take sides, but we must take action.

From that discussion emerged several principles that now guide our collective reflection. We recognized that taking sides in international conflicts is neither feasible nor desirable. In the post-truth era, facts are often contested, and the lines between aggressors and victims are blurred by disinformation, historical grievances, and shifting geopolitical interests. Condemning a "country" risks harming our members who live there, many of whom are themselves victims of their governments and their wrongdoings. Moreover, to single out one conflict while remaining silent on numerous others, including the acts of violence against the environment, would be ethically inconsistent.

As cross-cultural psychologists, our moral duty extends beyond symbolic statements. We have the tools, theories, and insights to foster peace, understanding, and resilience. That is where our true power lies. Therefore, we are developing a principled framework to respond to petitions from our members. This framework emphasizes respect, transparency, inclusivity, and consistency. It ensures that every petition we receive is treated seriously and compassionately, while safeguarding our scientific and ethical integrity.

These principles remind us that *not taking sides does not mean doing nothing*.

Instead, it calls for thoughtful, multifaceted action. Following this spirit, the Executive Committee recently discussed several constructive pathways that go beyond issuing statements to condemn a particular country. Among these are:

- Creating safe platforms for dialogue, where members can share perspectives and experiences without fear or judgment;
- Facilitating art and creative collaboration, as a form of collective empathy and expression transforming grief into shared humanity;
- Reviving humanitarian initiatives, such as support programs for scholars and students affected by war or displacement; and
- Collaborating with international bodies, such as IUPsyS, to pursue broader, collective declarations that reflect the voice of the global psychology community.

We are currently evaluating these options. These are not theoretical ideas; they are practical manifestations of who we are, scholars committed to understanding the human condition in its diversity and complexity.

In the long term, I believe our contribution must extend further. We can develop evidence-based training programs, curricula, and interventions that promote conflict resolution, intercultural dialogue, and peace education. We can collaborate with colleagues in political science, sociology, and education to address root causes of conflict and prejudice.

To me, this is how we, as cross-cultural psychologists, contribute to world peace. We are a community uniquely equipped to translate empathy into impact. Our science allows us to see beyond borders, to listen across divides, and to foster understanding where polarization reigns.

Let us therefore reaffirm that neutrality is not indifference. It is a commitment to hold space for all, to protect the integrity of dialogue, and to act with both courage and care. In an era of deep fragmentation, IACCP's strength lies in choosing humanity.

#### **Mission**

#### **Publication types**

The ORPC publishes original content in a journal article format. The ORPC focuses on disseminating information for a wide audience and therefore it is not an outlet for publication of original empirical studies (unless these are specific showcases for a larger point).

The ORPC publishes overviews of fields of study, state of the art of theories and measurements, as well as expert opinion pieces on education-related developments.

#### **Guidelines for Authors**

Adam Komisarof and Plamen Akaliyski have published their paper, "New developments in Hofstede's Individualism-Collectivism: A guide for scholars, educators, trainers, and other practitioners," in the International Journal of Intercultural Relations (Elsevier, Vol 107). #### **Brief abstract:**

Introduced as a measure by Geert Hofstede in 1980, the cultural dimension of Individualism-Collectivism ("I-C") has dominated the field of cross-cultural research and guided intercultural trainers, educators, and other practitioners up to the present. In 2023, The Culture Factor, the global cultural analytics and strategy advisor company associated with Hofstede's framework, updated their I-C scores due to mounting concerns with Hofstede's operationalization and measurement of I-C. These newer I-C scores are derived from the work of Hofstede's former collaborator, Michael Minkov. We discuss three major sources of country-level scores associated with Hofstede's name that pertain to his cultural dimensions, present a synthesized overview of the new developments in understanding and measuring I-C as it pertains to Hofstede's work, and examine the suitability of both Hofstede's original work and Minkov's subsequent revisions to I-C for academic research, intercultural training, and education.

With coauthors **Chan-Hoong Leong** and **Travis Lim, Adam Komisarof** has published a new paper, "Social markers of acceptance in Japan: Examining acceptance criteria for immigrants of different ethnocultural heritages," in the International Journal of Social Psychology (published bilingually in English and Spanish by Sage). #### **Brief abstract**

This study utilized social markers of acceptance ("SMA") to understand whether and how Japanese host national inclusiveness changes according to immigrant place of origin. SMA are socially constructed benchmarks (e.g., linguistic proficiency or genealogy) that receiving nationals use in deciding whether to view immigrants as national ingroup members. Japanese nationals (N = 1,309) participated in an online survey to identify how SMA importance varied with perceptions of immigrant threat, contribution, status, and intergroup permeability toward immigrants from China, South America, and Western countries. Respondents became less inclusive toward all three groups if immigrants were viewed as posing high levels of threat. Differences in marker emphasis toward the immigrant groups were found for perceived immigrant contributions and intergroup permeability. Chinese were seen as the most threatening, Westerners as highest in status, and South Americans (who primarily do unpopular blue-collar jobs) as highest in contributions yet lowest in status—suggesting that Japanese view immigrant contributions primarily in terms of doing blue-collar work that Japanese eschew. Overall, the findings demonstrated the shifting role of SMA in constructing social boundaries depending upon the immigrant group being considered, with each boundary condition reflecting different obstacles and enablers for immigrants to belong.



# Introducing the EDUCATE Initiative: Supporting Professional Development for IACCP Members

The EDUCATE Initiative was launched to provide IACCP members, especially students and early-career researchers, with opportunities for professional growth, networking, and mentorship. Since its inception, EDUCATE has organized a range of activities, including starting with the Inaugural Forum in January 2025, which featured a Graduate Student and Early Career Research Colloquium and a Virtual Networking Café. We further hosted, a webinar series on Conceptualizations of the Self in the MENA Region, bringing together leading scholars for engaging discussions.

In 2025, EDUCATE also launched a mentoring program, matching over 60 mentors and mentees based on research interests and career stage, providing structured guidance and support. EDUCATE also maintained a strong presence at the IACCP Brisbane 2025 conference, where we shared resources, engaged with attendees, and raised awareness of our initiatives.

Look for us at the next IACCP conference in Belgium in 2026 to connect with mentors and peers, participate in workshops, and explore new opportunities to learn and contribute to the IACCP community.

EDUCATE continues to grow, offering workshops, webinars, and forums to advance professional development and foster collaboration across the IACCP community. 


